I. NAME OF THE TRUST:

II. INITIAL TRUST FUND:

The "AUTHOR" has contributed a sum of Rs. 1,001/- (Rupees one thousand one only) in cash by way of initial "Trust Fund".

III. The "Trust Property" shall consist of the initial trust fund contributed by the "AUTHOR" and also the funds contributed by the author of the trust and the other trustees

IV. The "TRUST" property shall vest with the "AUTHOR" and other "TRUSTEES" subject to the provisions of this Trust Deed for the fulfillment of the objects of the "TRUST". At present the "TRUST" does not have any immovable property.




2. **Sri Mukund Ananda M.P.**, aged about 42 years S/o Late M. Purushottam residing at No 4, oak tree place, Brigade Millennium, J.P.Nagar, 7<sup>th</sup> Phase, Bangalore 560 078 shall be the Life time Secretary of the TRUST

XI. TERM OF OFFICE OF THE TRUSTEES:

1. The term of the office of the trustees shall be at WILL
2. Notwithstanding what is provided in sub-clauses 1 above the "TRUSTEE" shall cease to hold office and there shall be a vacancy on the occurrence of the following events:
  - a) If He/She is adjudicated insolvent or if he/she applies to be so adjudicated.
  - b) If He/She is convicted of any offence involving moral turpitude.
  - c) If He/She is found to be of unsound mind (by a court of competent jurisdiction)

In the event of death or resignation the vacancy shall be filled by the remaining trustees by nominating any persons from the family of the deceased or outgoing trustee.

XII. The president shall have powers to carry out the objects of the "TRUST" on the advice of the Board of Trustees.

XIII. POWERS OF THE TRUSTEES:

The Trustees shall have powers and authority to administer the "TRUST" and its properties and funds and to do all acts, duties and to promote and achieve the objects of the Trust without prejudice to the generality of the foregoing, the Trustees shall have powers and authority for the purpose of this "TRUST".

- a) to borrow monies with or without security and to repay the same.
- b) to enter into any contracts vary and rescind them.
- c) to open Bank accounts and provide for operations thereon from time to time.
- d) to give gifts, grants, endowments and donations in cash or kind.
- e) to institute, prosecute and defend all suits legal and other proceedings.
- f) to appear and act before courts, Tribunals, Governmental and other public authorities.
- g) to appoint, terminate, dismiss, suspend and otherwise deal with the employees of the Trust and its Institutions.
- h) to apply the properties and funds of the Trust for all or any of the objects, for which it is established, as may be determined by the Trustees from time to time.
- i) to decide from time to time the welfare activities and projects to be undertaken for the fulfilling the objects of the Trust.





- j) to frame rules and byelaws for management of the Trust, its properties and proceedings of the Trust and to amend or rescind the same from time to time subject to indemnity.
- k) to incur all necessary expenditure connected with the Trust.
- l) to consider the suggestions for the promotion of the objects of the "TRUST".

XIV. TRANSACTION OF AFFAIRS BY THE TRUSTEES:

The Trustees may meet as often as necessary for conduct of the affairs of the "TRUST". The president, in consultation with other Trustees shall arrange for meetings of the Board of Trustees. At least 3 days notice in writing shall be given for the meeting of the Board of Trustees, provided however, the president shall have powers to call for the meetings at much shorter notice for transacting any business considered by him to be urgent.

## XV. DELEGATION:

The Board of Trustees, from time to time, delegate to one or more their powers and duties as they deem fit subject to their retaining the ultimate control and supervision.

## XVI. ACCOUNTS:

The "TRUST" shall open account/s in one or more Nationalised and Scheduled Banks and deposit the amounts received for and on behalf of the "TRUST". The Bank accounts shall be operated by the President along with secretary.

The Trustees shall duly maintain true and correct account of all its assets, liabilities, receipts and expenses of the Trust and correct records of the Meetings and deliberations.

The year of the account shall be from 1<sup>st</sup> April or from the date of commencement of the functioning of the Trust to 31<sup>st</sup> March of succeeding year. It shall, however, be open to the Trustees to change the accounting year of the "TRUST", if they so desire, according to their convenience by passing a Resolution to this effect in the Board.

The Board of Trustees shall get the accounts of the "TRUST" duly audited by a Chartered Accountant every year.

## XVII. INDEMNITY-

The Trustees shall keep indemnified and harmless by the Trust against any action or proceedings, cost or claims, demands or liability for anything done by them in good faith pursuant to the power and authority vested in them under this Deed.

XVIII. AMENDMENT TO THE TRUST:



- (d) To institute, prosecute and defend all suits legal and other proceedings.
- (e) To appear and act before courts, Tribunals, Governmental and other public authorities.
