

The Grievance Redressal Committee will convene meetings on a fortnightly basis to review and address the grievances received.

## 3. Resolution of Grievances:

- o Upon receiving a grievance, the Committee will discuss and attempt to resolve the matter
- If the complainant is satisfied with the resolution, the Committee will forward the grievance and its decision to the Appellate Authority (Principal) for final approval.

## 4. Appellate Decision:

The Appellate Authority shall provide the final decision on the grievance within 3 working days from the date of its receipt by the Appellate Authority.
